### LRC Assists in Search for Missing Amber Dubois in Escondido, CA

Klaas Kids Foundation in Petaluma, CA, asked the Laura Recovery Center to help coordinate the search for Amber Dubois. Dawn Davis and Suzanne Slavin, LRC staff, flew to California on March 5th and spent several days organizing the search and training community search volunteers.

Also there to support the search efforts were Mark Klaas, father of Polly Klaas, and Brenda and Damon van Dam, parents of Danielle van Dam. Both Polly and Danielle were abducted and murdered. Close to 500 volunteers searched the rugged terrain on foot and using ATV's and 4 wheel drive vehicles. Over 150,000 flyers were distributed. The core volunteers trained by LRC are continuing the search and conducting ground searches every weekend.
